**One (1) Year Limited Warranty**

Lucas Metal Works extends this limited warranty to the original Buyer listed in the signatory below and warrants that its Ground Hog™ Arena Tool will remain defect free for one (1) year from date of purchase. See exclusions.

LIMITED WARRANTY EXCLUSIONS

1. This warranty does not cover normal wear items, including but not limited to, bearings, ground engaging parts such as, teeth, ripper points, blades, cutting edges, pilot bits and auger teeth.
2. This warranty does not cover maintenance, service or adjustments.
3. This warranty does not cover damage due to misuse, negligence, accidents or improper maintenance.
4. This warranty does not cover damage due to improper application, installation, adjustments or setup.
5. This warranty does not cover improper modifications of product.
6. This warranty does not cover disassembly of components, i.e. pumps, gear boxes and motors.
7. This warranty does not cover replacement parts not supplied by Lucas Metal Works a/k/a The Ground Hog.
8. Acts of God, falling objects, explosions, fire, external forces or other circumstances beyond our control.
9. Rust or degradation caused by improper storage, weather, exposure to water.
10. Normal wear and tear.

WARRANTY STATEMENT

Our obligation under the Limited Warranty shall be solely limited to repairing or replacing any part (see non-covered items) free of charge that, according to our judgment, show evidence of a defect in quality of workmanship or materials for the stated twelve (12) month warranty period. All defective parts must be routed directly to Lucas Metal Works a/k/a The Ground Hog with freight or delivery charges to be prepaid. This Limited Warranty shall not be interpreted to render Lucas Metal Works a/k/a The Ground Hog liable for any injury or damage to persons, business or property of any kind nor expenses or losses incurred for labor, supplies, substitute machine rental, or for any other reason. Repair or replacement parts are subject to the supply conditions at the time of repair or replacements, which may directly affect our ability to obtain material and/or replacements parts. Lucas Metal Works a/k/a The Ground Hog reserves the right to make improvements in design or changes in specifications at any time without incurring any obligations to owners of previous purchased units. No one but Lucas Metal Works a/k/a The Ground Hog allowed to alter, modify or enlarge this warranty nor the exclusions, limitation and reservation at any time.

Allow sufficient time to resolve all issues pertaining to this Limited Warranty claim.
